ENROLLMENT OF GRADE 11 LEARNERS IN PILOT SCHOOLS SUBJECT

OF THE STRENGTHENED SENIOR HIGH SCHOOL PROGRAM

DATE : July 28, 2025

In accordance with the Memorandum issued by the Office of the Secretary (OSEC) to the Policy and Planning Service (PPS), Pilot Schools participating in the Strengthened Senior High School (SSHS) Program and concerned Regional Offices (ROs) are hereby directed to align the enrollment of Grade 11 learners with the newly launched SSHS tracks in the Enhanced Basic Education Information System (EBEIS) and Learner Information System (LIS).

1. In the EBEIS, Regional Planning Officers (RPOs) shall select the "School Implementing Strengthened SHS Curriculum" in the SHS Program Offerings and tag the 891 Pilot Schools whether offering "Academic Track (Strengthened)" and/or "Technical Professional". This tagging feature will be available only to these designated schools starting July 30, 2025.

- 2. Once the RPOs update the SHS Program Offerings, the Pilot Schools can create sections based on their assigned tracks in the Senior High School tab of the LIS and can begin enrolling the Grade 11 learners to "(Strengthened SHS) Academic Track" or "(Strengthened SHS) Technical-Professional (TechPro) Track".
- 3. The Pilot Schools who have already enrolled Grade 11 learners to General Academic Strand (GAS) and Technical-Vocational-Livelihood (TVL) should create sections and reassign the learners to "(Strengthened SHS) Academic Track" or "(Strengthened SHS) Technical-Professional (TechPro) Track".
- 4. Attached to this advisory is the user guide on updating the SHS Program Offerings in EBEIS and enrolling Grade 11 learners to SSHS Program in the LIS. The Strengthened Senior High School Technical Working Group (TWG) Secretariat will also circulate the user guide to the Pilot Schools and their respective ROs and SDOs.
- 5. Enrollment in the LIS will continue for the rest of the school year, consistent with DepEd Order No. 17, s.2025. However, all schools are encouraged to encode in the LIS as soon as possible so that the system can capture official enrollment numbers and updated learner records.
